

SACRAMENTO VALLEY LFL CHAPTER MINUTES- JULY 17, 2005

The meeting was opened at 1:05 P.M. with prayer by President Roger Bohnhof. There were twelve members in attendance.

The agenda was approved as presented. The minutes of the previous meeting were approved as read.

The treasurer's report was made and filed for review, with an ending balance of \$1,137.08. However, there was no beginning balance. Treasurer James Brauer Jr and former treasurer Betty Buchholz will get together to reconcile differences between previous reports and the bank statement. Betty has provided the list of recent PayPal charges; James will look further into what these were from.

Unfinished Business

Nathan Brauer is trying to develop a new and updated website for the Chapter (in between school responsibilities).

Lois Brauer really enjoyed the April meeting (with the speaker on assisted suicide) and was pleased with the turnout. She thanked the ladies who arranged for the lunch.

Lois asked National Director Dr Lamb for a CD copy of his February presentation, but has not received it yet.

New Business

Roger and others received a Temporary Restraining Order to prevent their speaking to people at an abortion clinic in the Arden area. On the advice of an attorney, they will not fight the order. On July 30, they will go to the clinic, outside the specified boundaries, for a silent vigil. Roger also witnesses at two Planned Parenthood locations. He asked for our prayers for these efforts.

Sherry Osterli encouraged prayer support for those that go to the sites, and for judges who can understand the pro-life position.

The National LFL Convention will be held November 11-13, 2005 in St Louis, MO. Registration will have to be in by mid-October. After some discussion, it was moved, seconded, and carried to spend up to \$1000 towards the expenses for one or more individuals to attend on our behalf. Another motion was passed to authorize \$100 to purchase any recordings of the conference sessions that will be available. Lois will consider going.

Roger suggested that we have another sex education/abstinence program. (The last one we had was in March 2003.) After discussion, a motion was passed to hold it on March 11, 2006. Lois and James Jr will head the planning committee. Lois

will speak to the parish nurse at Holy Cross Lutheran in Rocklin about providing or suggesting a program.

This year's Life Chain will be held on October 2, 2005. Norm Holt will be attending a planning meeting for it later this month.

James Jr asked if we had enough supplies for distribution on hand and Norm (Supplies Chairman) stated we did.

Final comments- Roger thanked Betty Buchholz for her service as Treasurer, and the new officers (Vice President Norm Holt and Treasurer James Brauer Jr) for agreeing to serve this year.

He has received a new version of the "For Life" video from National in DVD format.

Adjourned at 2:45 P.M. Closed with prayer by Roger.
