The letter asked questions as to the implementation of the grant to be sent back to them. We have 2 years to put an event in place. When we receive the grant money Linda will put it in a separate bank account the Safe Credit Union.

Lois spoke with Andy Matzke, the youth minister of Sun River Church, who is interested in partnering with us to put on an event this fall. She will call him and set up a date and meeting time and place with our board.

Gail Triano is interested in becoming the President and will pray about it and give us an answer at a later date.
